The vendor/commissioning party hereby instructs Global Dressage Auction B.V. (hereinafter referred to as: 'GDA')/the commissionee to auction for the highest bid the aforementioned foal, if admitted to the auction, on behalf of and for the account and risk of the vendor/commissioning party and to sell this foal, after assignment, on behalf of and for the account and risk of the vendor/commissioning party to the bidder/buyer, which instruction GDA/the commissionee hereby accepts.

The vendor/commissioning party declares to be aware of and agrees to the registration fee and the regulation relating to the auction commission and the auction commission fee payable on those grounds.

The content of the GDA auction terms and conditions is applicable to this commission contract and to the contract of sale to be concluded between the owner as the seller and bidder/buyer and the seller/commissioning party declares to be aware of this and agree to it.
